By Mr. Ertel:

- Q. State your full name, please?
- A. Dwayne F. Gleckner.
- Q. Your occupation?
- A. I am a life insurance agent.
- Q. For whom?
- A. For Baltimore Life.
- Q. How long have you been a life insurance agent?

By Mr. Fierro:

Does that have a bearing on this case? Otherwise,

I object.

By Mr. Ertel:

Just to give background.

By Mr. Fierro:

I object to that.

By The Court:

I won't strike it, but let's proceed with what the offer was.

By Mr. Ertel:

- Q. Mr. Gleckner, do you also have a part-time occupation or duty?
- A. Yes, I am in the Civil Air Patrol Squadron Commander.
 - Q. What is your rate or rank?

- A. Captain.
- Q. As part of the Civil Air Patrol, did you join in the search for Jennifer Hill?
 - A. Yes, I did.
 - Q. How long were you searching for her, do you recall?
 - A. A week, around that.
- Q. Did you have the occasion on or about the 28th of

October, 1974, to discover her body?

A. Yes, I did.

By Mr. Ertel:

Wouldyou change that date? We soft from purpose

I beg your pardon. Q. I beg your pardon, 1973, on or about the 28th of why wishe say that in the October, 1973?


A. Yes.

- Q. Would you describe where you found the body, what time and what day of the week it was?
- A. Well, it was on a late Sunday afternoon, approximately just a little bit before 4:00 in the cornfield off of Sylvan Dell Road.
- Q. Would you describe, if you will come down please, and ask you if you can identify what is marked as Commonwealth's Exhibit No. 37, which is a photograph on the board, if you can just stand over here where I cam, can you identify that photograph?
 - A. Yes.
 - Q. What is that of?
 - A. That is of the field where I found her.

- Q. What is, all right, canyou describe what your path of travel was just prior to the time you found the girl?
- A. Yes, I was coming in a direction towards South Williamsport through the cornfield, probably about a half dozen of so rows until I came to the road that goes back through the field, and then I went back that road towards the tanks.
 - Q. What kind of boots were you wearing?
 - A. Jump boots.
 - Q. Did they have anymails or anything in them?
 - A. Not that I remember, I don't know.
 - Q. When you went back that road, what did you observe?
- A. Approximately half way back and off to the left side of the road I seen the body.
- Q. Looking now, can you point out on that photograph where the body was located approximately?
 - A.) Yes, right here in this area.
- That shows there is a hole there, was that a hole 5 And will create there when you....

 - Were you there when that hole was made?
- Yes, I was there, I was not back in that area, but I was.
 - In the vicinity?
 - Yes.
- If I put an "x", would that be the approximate location?
 - That would be the approximate location.



- Q. I will write the word "body", now turning to Commonwealth's Exhibit No. 36, can you identify that photograph?
- A. Yes, that is also the same area taken from a different angle.
- Q. Now, can you show the road you walked back on that particular photograph?
 - A. That one right here.
- Q. Can you locate the location of the body where you saw it?
 - A. Yes, a little over half way back.
- Q. I will mark an "x" again and the word "body". Turning to Exhibit No. 45, canyou recognize that map of the area?
 - A. Yes, this is the Sylvan Dell Road along here.
- Q. Can you identify the road which you identified on the previous Exhibit?
 - A. It would be back to the tanks.
- Q. Now, if you will return to the stand. Where were you in the roadway when you observed the body?
 - Y. A. Along the left side of the road.
 - Q. What did you do when you observed the body?
- A. Turned around and went back out through, out to the center of the road and out to the Sylvan Dell Road.
 - Q. What was your next thing?
 - A. The next thing was to radio back to our

Headquarters.

Q. What did you do as far as the area was concerned?

A. Sealed it off at that point.

Q. Did you allow anybody to go back in there?

A. No, the only personnel that were back in there was Major Huntzinger, who is the Coordinator for the mission or Mission Commander and he came out right after I radioed to confirm what I had found. He went back in there, and turned around and came back. The next people to go back there were the Police.

Q. I show you what is marked as Commonwealth's Exhibit No., and ask you if you can identify that?

A. Yes, I can.

- A. It is the body that I located.
- Q. Can you tell me if there is any difference between that photograph and what you observed when you went back that road?
 - A. I can't see any difference, no.

The photographs are available and he is available for cross examination.

CROSS EXAMINATION

By Mr. Fierro:

- Q. Mr. Gleckner, whatever you testified to, is that your complete knowledge of this case?
 - A. Yes.
 - Q. Were you on foot when you discovered this body?
 - A. Yes, I was.
 - Q. Were you alone?
 - A. Yes.
- Q. The area that was marked by the District Attorney on these two Exhibits, the photographs, it shows like an indentation in the cornfield, they were not there when you discovered the body, apparently that area was cleared out?
 - A. Yes.
- Q. Were you there when that area was cleared out?

 A. I was not at the area when it was cleared out,
 I know of it being cleared out.
- Q. You walked along this, we will call it the cornfield road, it is a private road, isn't it?
 - A. Yes.
 - Q. The one you pointed out?
 - A. Yes.
- Q. On both of these Exhibits they look like indented black marks and this indentation here which forms sort of a short

"T", that is the area that was cleared out of the cornfield where the body was found?

Q. You walked along this road, and you looked in between these rows of corn and saw this body?

- A. Yes.
- Q.) You did not approach the body?
 - A. No, I did not.
- Q. What did this Major do when he came upon the scene, did he walk along the same road?
 - A. Yes.
- Q. Walk approximately up to the same position where you were and saw the body?
 - A. Yes.
 - Q. And he did not walk into that area?
 - A. No.
- Q. Of course the Police came, were you there when the Police came?
 - A. Yes, Sir, I was.
- Q. Did they also walk along this private road between the cornfields?
 - A. Yes.
 - Q. Did they walk towards the body?
- A. Not to the best of my knowledge, I don't know for sure.
 - Q. You don't know?
 - A. I don't know.

- Q. Of course, when you first saw this body, Mr. Glecky or Captain, whatever you want to have me call you, I don't care, do you mant me to call you "Captain"?
 - A. No.
- Q. All right, when you first saw this body, Mr. Gleckner, you must have been only a few feet away from it?
 - A. I was.
 - Q. I would suspect two or three feet?
 - A. Probably not more than five, at the very most.

- Q. Even on this picture, Commonwealth's Exhibit No. 1, it is as close to the road as the body, isn't it?
 - A. It appears to be, yes.
- Q. Well, according to the picture, ifyou say it is different, say so?

By Mr. Ertel:

I object to the interpretation of the picture.

By The Court:

Well, it is what he recalls at the scene. Proceed,

Mr. Fierro.

By Mr. Fierro:

Q. Is the body of Jennifer as shown in this Exhibit

substantially accurate as you saw it at the time, that day at 4:00?

- A. Yes.
- Q. And as far as you are concerned, this
- Exhibit No. 1 substantially and accurately reproduces what you saw?
 - A. Yes.
- Q. Except for one thing, isn't that correct, and that is this white object on the righthand side of the picture?
 - A. It could have been there, I don't know for sure.
 - Q. Did you see it?
 - A. I don't remember seeing it.
 - Q. Well, it is a rather large, white object, isn't it?
 - A. Yes.
- Q. And it is prominently displayed in this picture, isn't it?
 - A. Yes.
- Q. And it is close, at least on this picture, as Jennifer's feet are to the road, isn't that correct?
 - A. Yes.
 - Q. And yet you say you did not see that white object?
 - A. No.

By Mr. Ertel:

I object, he did not say he didn't see it.

/ A. I said I don't remember seeing it.

By Mr. Fierro:

Q. You don't remember seeing it, you remember seeing the body?

- A. I will never forget that.
- Q. Now, by looking at this do you know what that white object is, or don't you?
 - A. No, Sir, I don't know for sure.
 - Q. Do you want to guess?
- A. It looks like it could be a "t" Shirt or something like that.
 - Q. Could be a "T" shirt or something like that?
 - A. Yes.
 - Q. It is white, isn't it?
 - A. Yes.
- Q. And even on this photograph it is in plain view, isn't it?
 - A. Yes.
- Q. Now, you discovered the body, and if you look at this photograph, tell the Jury how far away from the body that white object is?
 - A. Probably about four feet.
 - Q. Do you know what happened to this white article?
 - A. No, Sir, I have no idea.
 - Q. Do you know if the Major saw this white article?
 - A. I have no idea whether he saw it or not.

I have no objection to them being received in evidence, but I don't like, the Court of course will decide, but I don't like the idea of the photographs, or any exhibits being passed around the Jury while testimony is being taken. By Mr. Ertel:

If you don't mind, I will let them look and pass them around, and I won't ask any questions.

By Mr. Fierro:

This will dissipate time as well.

By The Court:

You have no objection to the photographs?

By Mr. Fierro:

None.

By The Court:

The Court has not seen the photographs yet, I will reserve my ruling. Proceed.

By Mr. Ertel:

I think that it is important that the Jury be able to see what we are talking about as we go.

By The Court:

Are your next witnesses going to talk about the same



thing?

By Mr. Ertel:

Yes, Sir, and that will give them some explanation of what he is talking about and make it easier for them to visualize.

By The Court:

May I see Counsel at Side Bar?

(Side Bar consultation not made a part of record.).

By The Court:

They are admitted, but the request of passing them through the Jury at this time is denied.

(Commonwealth's Exhibits Nos. 1 and 2 admitted into evidence.)

By The Court:

Any further questions of this witness?

RE-DIRECT EXAMINATION

By Mr. Ertel:

- Q. What was the tread like on your shoes, if you recall?
- A. Fairly worn. It was at one time a square design on the sole.
 - Q. What do you mean by "square"?
- A. It had little squares or diamonds, something similar to that on the sole.
