- Q. Where do you live, Gary?
- A. 342 Kane Street.
- Q. Where is that in relation to the St. Lawrence

#### School?

- A. About a half block down the street.
- Q. On Kane Street?
- A. Yes.
- Q. Going back to the 19th of October, the day you had off school, did you have the occasion to see Jennifer Hill that day?
  - A. Yes.
  - Q. Where did you first see her?
- A. I first saw her I was playing kick ball with her the St. Lawrence Playground.

- Q. At that time, what was she wearing, if you recall?
- A. A blue and white jersey and a pair of jeans.
- Q. How long did you play kick! Il that morning, if you recall?
  - A. I can't remember.
