By Mr. Ertel:

Jeffrey Whiteman.

JEFFREY L. WHITEMAN, being duly sworn according to law, testified as follows:

DIRECT EXAMINATION

By Mr. Ertel:

Q. State your full name, please?

A. Jeffrey Whiteman.

Q. Where do you reside?

A. 342 Kane Street.

Q. The boy that just testified is your brother?

A. Yes.

Q. How old are you?
