And Now, to-wit, Thursday, February 21, 1974, beginning at 9:30 A.M., EDST, the trial in the above-captioned matter was continued before the Honorable Charles F. Greevy, President Judge, and a Jury, in Court Room No. 1, at the Lycoming County Court House, Williamsport, Penna., at which time the Defendant was present with Counsel, and the following proceedings were had:

CHIEF OF POLICE CHARLES E. SMITH, being duly sworn according to law, testified as follows:

DIRECT EXAMINATION

By Mr. Ertel:

Q. State your full name and occupation?

A. Chief of Police, Charles B. Smith, South Williamsport.

Q. How long have you been Chief over there?

A. Four years.

Q. Chief Smith, I show you Commonwealth's Exhibit No. 42, can you identify that just generally as to what it is?

A. It is a map of a section of the Borough of South Williamsport.

Q. How, Chief, will you come down and stand to the side so the Jury can see it. It obviously has streets marked on it, can you point out the approximate location of the Hubbard home? First, how do you know where the Hubbard home would be?

A. Hill Street and Central Avenue, at the corner of Hill and Central Avenue I lived for nine years.

Q. Where did the Hubbards live in relation to your home?

A. It would be the third house down.

Q. Will you put a big "X" and write "Hubbard Home" please in the approximate location?

A. (Witness indicates.).

Q. Now, that would be the whole block facing onto Central Avenue, is that correct?

A. Yes.

Q. Somewhere in this block between Hill and Clinton Street, is that correct?

A. Yes.

Q. Now, will you come down and can you approximate where the Hill home is located?

A. That is located in the 300 block of Hastings Street.

It is the 6th home down north from Central Avenue.

Q. Can you put approximately where the Hill home would be located?

A. (Witness indicates.

Q. Can you also locate there the approximate location of the St. Lawrence School?

A. This would be this whole block in here, the Church and the School.

Q. Would you label that, please? (Witness indicates.).

Q. Can you identify where the Clabaugh residence is?

A. The Clabaughs live on the corner of West Central Avenue and Clinton Street, which would be, it is on the southwest corner.

Q. Would you label the Clabaugh home, please?

A. (Witness indicates.).

Q. Where does the Whitemans live, do you know?

A. They live in the 300 block of Kane Street, just which house I don't know.

Q. Do you know where the Nevel home is located?

A. The 500 block of Howard Street, the first home facing Howard.

Q. Can you approximate or locate that home on that?

A. Yes, it would be this Section 199.

Q. Mark that, please?

A. (Witness indicates.).

Q. Now, can you also locate the location of the Hum-Dinger, what is that on?

A. That is the 700 block of West Southern Avenue, right in here.

Q. Would you mark that, please?

(Witness indicates.).

Q. Do you know where the Mauro Music Store is located?

Wellow C

A. This is not on this map.

Q. Can you show us by pointing to the area where it would be off of, what street is it on?

A. East Second Avenue. You have to come down this street here.

Q. In other words, looking at Commonwealth's Exhibit No. 42 it would be somewhere off of the righthand side as you are facing the Exhibit?

A. Yes.

Q. All right, now, Chief Smith, can you tell us where Sylvan: Dell area is located?

A. That would be east of the Borough, it is not on this chart.

Q. Do we have charts with that on?

A. Yes.

Q. I show you what is Commonwealth's Exhibit No. 43, can you describe what that depicts?

A. This is the eastern end of the Borough of South Williamsport.

Q. Would the Mauro Music Store show on there somewhere?A. No, it is not.

Q. Would you describe what it shows and what roads it

shows in relation to Sylvan Dell?

A. This would be 15 coming north into South Williamsport and Williamsport. This is East Second Avenue which runs in an eastern direction in the Borough towards the Sylvan Dell.

Q. That goes towards Sylvan Dell?

A. Yes.

Q. If you were proceeding from South Williamsport to Sylvan Dell, you could go that way?

A. Yes.

Q. Commonwealth's Exhibit No. 44, what does this depict?

A. This section here is the Sylvan Dell area.

Q. If you were coming off of the other Exhibit, would you come on down Second Avenue?

A. Yes.

Q. And come on to what, the Sylvan Dell Road eventually? A. Yes.

Q. It is on this next one here?

A. East Second Avenue is right here, East Second Avenue would pick up, following East Second Avenue here across the railroad tracks and follows the Susquehanna River down here into the Sylvan Dell area.

Q. Is this the road here that is the broken line?A. Yes.

Q. Would you follow the road through, please, where does it eventually wind up?

A. You can follow it down over the side of the mountain

into the Old Lookout Road which comes out onto Route 15 south.

Q. Now, looking at Commonwealth's Exhibit No. 45, what does that depict?

A. This depicts the road up along the river again, which continues down here to the Arco Station which you make a sharp righthand turn across the railroad tracks and up over the mountain.

Q. You make a sharp right as you are driving on the road, across the railroad tracks again, and up towards the Lookout area, is that correct?

A. Yes, Sir.

Q. Now, here are a series of round circles, Chief, if you will identify these, what are these round circles?

A. They are storage tanks, Arco.

Q. Arco Storage tanks?

A. Yes.

Q. What is the big round circle?

A. That is a new tank that was under construction within the last couple of years.

Q. That is the old tank and there is another one over here?

A. Yes, Sir, this is also a big tank.

Q. How, there is a broken line coming off of the Sylvan Dell Road down towards what is as you identified as the large tank, what is that road?

A. It is just a lane into a cornfield.

Q. Where does it terminate?

A. It stops right in here, this is like a dike around this tank, it is approximately from six to eight feet high, that lane stops at that dike.

Q. Do you know the approximate location on there where the body was..... By Mr. Fierro:

I thought that he had this witness on here to identify maps, and then if we are going to go further then I want him to....

By Mr. Ertel:

I am trying to put things on the map. By Mr. Fierro:

I know that you said you wanted him on By Mr. Ertel:

I object to this, if you would like to approach Side Bar, I would be happy to.

By The Court:

Side Bar, Gentlemen.

(Side Bar consultation not made a part of the record.). By The Court:

You are going to withdraw the question? By Mr. Ertel:

Yes,

Q. I show you marked as Commonwealth's Exhibits Nos. 27 and 28, can you identify those?

A. Yes, I can, that is the Arco Storage Tanks.

Q. Now, in relationship to the map, the series of small white tanks that we see as I point them out on the two exhibits....

A. I don't know if they did or not.

Q. You don't know and you were there?

A. Yes, Sir.

Q. What is the matter, weren't you looking, Lieutenant?

A. Yes.

Q. You were looking for, I will withdraw that

question. You were looking for blood stains, if they were there?

A. Yes, Sir.

Q. Did you find any blood stains?

A. No, Sir.

Q. You were looking for evidence that might indicate

A. Yes, Sir.

Q. Did you find any evidence, tell this Jury, did

you find any evidence that indicated there was a struggle in that car?

A. I didn't.

Q. Well, you were looking for it though, weren't you?

A. I said there were two Troopers making an investigation.

Q. I am asking you about you?

A. I am answering for myself, I didn't.

Q. Did you find any evidence in that car on October 31st when you examined it that indicated there was a struggle in that car?

A. I didn't, Sir.

Q. No, you didn't, that is your answer?

A. Yes.

Q. How did you go about making this investigation, you,

I mean?

A. As far as my part in it?

Q. Yes?

A. I supervised the examination of the car.

Q. What does that mean, explain it to us?

A. I wanted to make certain that there was an examination made of the interior of the car for any evidence we could, would be noticable at that time. Two of the people who conducted the investigation were in charge of, were making the check of the inside of the car.

Q. Under your supervision?

Hymick.

A. Yes, Sir.

Q. And in your presence?

A. But I wasn't there during the entire examination of the car.

Q. But you know, they reported to you concerning the results, didn't they?

A. Yes, Sir.

Q. So that you would know whether anything was found or not, because these men were under your supervision, weren't they?

A. That is right.

Q. Now, tell us, these men who were under your supervision, what did they remove from this car?

A. They removed samples of mud and a few other items from the inside of the car.

Q. I am not satisfied with your saying "a few other items", I want to know what they were?

A. Anything that a vacuum cleanor could pick up off the flooror the seats.

Q. Do you know what that was?

A. No, Sir, everything that was placed in the bag and taken to the State Police Crime Laboratory at Harrisburg.

Q. Did you make a list of that before it was sent down?

A. Just what was, whatever was scooped up by the sweeper was placed in a bag and taken down.

Q. I asked you did you make a list of what was taken

down?

A. No, Sir, I didn't.

Q. Who did?

A. The men who were making the, conducting the examination of the car.

Q. That is the fellows you have already told us about?

A. Yes, Sir.

Q. Did you see the results of that Laboratory examination?

A. Yes, Sir.

Q. Do you have it here?

A. No, Sir, the man in charge from the Laboratory has the results.

Q. Did you personally make an examination, I am not talking about supervise?

A. Of what, Sir? I made a lot of examinations.

Q. Of this carf

A. The interior of the car?

Q. Yest

A. Yes, Sir.

Q. You did?

A. Yes, 3ir.

Q. Okey, while you were making the personal examination, did you see any blood inside of this car?

A. No, Sir, I didn't.

Q. Did you see any women's clothing inside of this

Q. Did you see the fabric, if it was fabric or whatever the textile or otherwise of the seats, were they destroyed in any way other than normal wear and tear? By Mr. Ertel:

I object, how can a person tell?

By Mr. Fierro:

Let him say it.

By Mr. Ertel:

I do object.

By The Court:

Q. Do you understand the question?

A. Yes, Sir.

Q. The objection is over ruled.

By Mr. Ertel:

I will withdraw the objection then.

A. From my observation, I couldn't say for certain.

By Mr. Fierro:

Q. You couldn't say what for certain?

A. Anything about the wear of the fabric in the inside of the car.

Q. Did anything appear to you in the total interior of the car that it had recently been destroyed in any way, recently destroyed and ....

A. Not to me, Sir.

Q. Did you look for fingerprints in this car?

A. I didn't, Trooper Keppick did.

Q. Did you find any hair in this car?

A. I didn't, Sir.

Q. But we know somebody did, don't we?

A. That is correct.

Q. Who was it that found that hair, do you know?

A. No, Sir.

Q. You don't?

A. No, Sir.

Q. That wasn't found the day you took the car in,

was it?

A. No, Sir.

Q. Did you or your men on October 31st vacuum the interior of this car?

A. Not until the following day.

Q. All right, the following day, but it was in Police custody, wasn't it?

A. Yes, Sir.

(April

Q. But you were there when it was vacuumed?

A. No, Sir.

Q. Do you know who did it?

A. Trooper Gomb was one of the members, do you know whether anybody tried to get any fingerprints out of this car?

A. Yes, Sir.

Q. Who was it?

A. Trooper Kappick.

Q. Are they the two Officers who the next day,

presumably November 1st, did a thorough interior examination of the car or were there others?

A. No, they were the two.

- Q. That would have been November 1st, wouldn't it?
- A. The first, and it was a couple days after that.
- Q. Also November 2nd?
- A. I don't know the exact dates.
- Q. There are some records about this somewhere?

A. Yes, Sir, there is.

Q. Did you ask Kim Hubbard for anything else except the boots and car, like, for example, did you ask him, excuse me, did you ask him for his clothing?

A. No, Sir, I....are we talking about clothing?

- Q. Yes?
- A. No, Sir, I didn't.
- Q. Somebody in your presence?
- A. Not in my presence.
- Q. Did you see any clothing that may have been surrender-

ed by Kim?

A. No, Sir, I don't.
Q. Did you interrogate him?
A. Yes, Sir, I did.
Q. For how long?

By Mr. Ertel:

I object to this, we are going to recall him for this purpose, he was only offered for the purpose of the car at this time.

By Mr. Fierro:

He is a Commonwealth witness, a member of the investigating team, while he is on the stand I think it is just as efficient if we go ahead instead of waiting for the District Attorney saying "We are going to recall him.", and furthermore, all of the questions concern the very meat of this case.

By Mr. Ertel:

I do not dispute all of these questions as to the interrogation of Kim Hubbard going to the meat of the case, however I am going to recall him in order and my case at this point, and I am entitled to proceed in an orderly fashion. By The Court:

Would you establish whether this was on the 31st or not, before I rule?

By Mr. Fierro:

Q. Did you interrogate him on the 31st? A. At his home, yes, Sir.

By The Court:

The objection is over ruled for the date of the 31st. By Mr. Fierro: Q. Now, we are still talking about October 31st, did you also interrogate him at the Borough Hall? A. Yes, Sir, I did. Q. So that you interrogated Kim Hubbard twice on October 31st? A. No, Sir, just once at his home. Q. How about Borough Hall? A. That was on a different date, Sir. Q. I was asking you about October 31st, how long were you in his house on the 31st? A. Approximately a couple of hours. Q. Did you, Lieutenant, spend a couple of hours interrogating this boy? A. No, we didn't spend that much time talking to him. Q. What were you doing there for a couple of hours?

- A. Talking to his Father and Mother.
- Q. And to Kim Hubbard?
- A. No, he was not home when we, when we first got there.
- Q. How long did you interrogate him that day?
- A. Approximately an hour.
- Q. An hour?
- A. Yes.
- Q. And I suppose you told him that he didn't have to

answer your questions, isn't that right?

A. Very true.

Q. And he voluntarily answered your questions, isn't that right?

Q. In other words, you gave him what we have known and what we know as the standard Miranda warning, isn't that what you gave him?

Q. And he didn't ask for one, did he?

A. Mo, Sir.

Q. Now, I would like to know, as they relate to this case, what questions you asked Kim Hubbard....

A. Concerning his activities on the 19th of October.

Q. And also concerning whether or not he saw Jennifer Hill, you asked him that, didn't you?

A. I don't remember if I asked him or somebody else did.

Q. Who would that somebody else be?

A. The people who were in my presence.

Q. Who are they?

A. 3gt. Peterson.

Q. You two men?

A. Yes, Sir.

Q. Between you two men on October 31st, didn't you question this boy over a period of an hour as to whether or not he saw Jennifer Hill that day?

A. During our conversation with him that was mentioned by Sgt. Peterson.

Q. Lieutenant, is this the only time you were in the Hubbard house?

A. I was there on two occasions.

Q. Is this the only time you interrogated Kim in the Hubbard house?

A. That is correct.

Q. Are you sure that the District Attorney wasn't

there with you?

....

A. Yes,Sir, he was.

Q. I thought you just, you said just this other Trooper

A. I said when I first come here that Sgt. Peterson and District Attorney, Hr. Ertel, was with me.

Q. Really, is that what you told us?

A. Yes, Sir, Idid say that.

Q. Wasn't the District Attorney asking questions also?

A. Yes, Sir.

Q. Well, then there were three of you asking Kim Hubbard questions in his house on October 31st, right?

A. Yes, Sir.

Q. And the District Attorney was there when you asked Kim to surrender his car and boots, is that right?

A. Yes, Sir.

Q. Now, this is not the last time that you questioned Kim, is it?

A. No, Sir.

Q. You questioned him thereafter, didn't you?

A. That is right.

Q. Somewhere in the course of your investigation

this thing about the white helmet became important, as you know, isn't that correct?

A. That is correct.

Q. Did you bother to find out where or when Kim Hubbard got this white helmet?

A. No, Sir, I didn't.

Q. Do you know if anybody did?

A. Not to my knowledge.

Q. So far as we know through you, Lieutenant, nobody

Q. Were you present when somebody from the Police showed this car to Mrs. Nevel and pointed out this white helmet on the ledge?

By Mr. Ertel:

I object to that, that is a statement and not a question.

By Mr. Fierro:

I am asking if he was present when this was done, he either was or wasn't.

By Mr. Ertel:

I object, it impliess that was done.

By Mr. Fierro:

Yes, I say it was done and I intend to prove it. By Mr. Ertel:

I would be happy to have you do it.

By Mr. Fierro:

You head it at the preliminary examination. By The Court:

Do you expect to follow it up? By Mr. Fierro:

I expect to follow it up through the District Attorney taking the stand or one of his Policemen. By The Court:

Q. Do you understand the question?

A. Yes, Sir, I do.

Q. You may answer, the objection is over ruled.

By Mr. Fierro:

Q. Were you present when these photographs were made of this car?

A. No, Sir, I was not.

Mr. Fierro, we are going to take a recess at this time. The Defendant and the Jurors are now excused. By Mr. Fierro:

He wants to talk to me.

By The Court:

Sheriff, you will arrange that they go in the other room over here reserved for Mr. Fierro.

Court is receased for ten...for fifteen minutes. (Recessed at 2:45 P.M. and reconvened at 3:00 P.M.). (Lieutenant Steven Hynick returned to the witness stand.). By The Court:

Proceed, Mr. Fierro.

By Mr. Fierro:

Q. Lieutenant Hynick, on October 31st when you were in the Hubbard house talking with Kim and Mr. and Mrs. Hubbard, was that the occasion that you told Mr. Hubbard, that is the Father, that there were more than two sets of footprints at the

scene where Jennifer's body was Bound?

A. Yes, Sir. Can I qualify my answer, Sir?

Q. Well, I was going to ask you another question, you answered the question.

By Mr. Ertel:

I believe the man is entitled to explain. By Mr. Fierro:

Some questions do not require an explanation. By The Court:

The Court does not feel an explanation is necessary, proceed.

By Mr. Fierro:

Q. And didn't you also tell him, these were your words, or substantially your words, that you couldn't tell whether it was two or more people whose footprings were down there where the body was found?

A. No, Sir, I did not.

Q. Well, what did you say about it?

A. We talked about shoe prints, a boot print and a sneaker print.

Q. You say "we", I am talking about you, what did you say?

By Mr. Ertel:

Q. Will you describe your role in this examination of the car?

By Mr. Fierro:

That is repetitious, it has been done twice. By The Court:

The Court will permit it however, the objection is over ruled.

By Mr. Ertel:

Q. Go ahead and explain?

A. My position is Lieutenant in the State Police, my role in this investigation was administrator to see that the proper persons were doing their job.

By Mr. Fierro:

I object to that, that is not responsive. By The Court:

Answer the specific question, 3ir.

By Mr. Ertel:

Q. What was your role in this investigation? By Mr. Fierro:

I object to that general, vague question, on the grounds that it is improper re-direct and repetitious. By The Court:

Q. In addition to what you testified to, what was your role in this specific case, Sir?

A. To see that the proper persons were assigned to different phases of the investigation. By Mr. Ertel:

Q. Incidentally, how many days after the disappearance of Jennifer Hill did you confiscate or get the car from Kim Hubbard, how many days had elapsed? By Mr. Fierro:

As I understand the District Attorney's original statement and the Court's ruling, I had to limit myself to October 31st, because he said he was going to recall this witness.

By The Court:

He is opening it up now.

By Mr. Ertel:

Now, wait a minute, if I may ....

By Mr. Fierro:

You may do it at Side Bar.

By The Court:

Side Bar.

(Bide Bar consultation not made a part of the record.). By The Court:

Mr. Ertel, do you want the question read back? By Mr. Ertel:

No.

By The Court:

Proceed.

By Mr. Ertel:

I have no further questions subject to recall. By The Court:

Mr. Fierro?

By Mr. Fierro:

Subject to what the Court and we discussed at Side Bar.

Q. Now, who was watching television with you?

- A. My daughter, Beth.
- Q. How old is she?
- A. 11.

Q. What grade of school is she in relation to Jenny

H111?

A. She was in the 6th grade and Jenny was in the 7th.

Denter M. M. M.

Q. Would you describe approximately what time of day you saw Jenny Hill?

A. 4:30.

Q. How do you establish that time?

A. Well, the program on television, well one was ending and the "Flintstones" were coming on.

Q. Which was ending, do you recall?

A. "Secret Storm".

Q. Now, will you describe what happened at that time of day and what you observed?

A. Well, I was seated at the couch, and she came up the street and she looked at my door, I had a Halloween decoration on and I asked my daughter who she was and she said "Jenny Hill", and I turned and kept watching and she got in the car.

Q. What car did she get into?

AL

A. A light green metallic car.

Q. All right, and where did you, would you describe what she did, what her activities were as she proceeded up the street, how you watched her and what she did?

A. She was looking around.

Q. Would you sort of show the Jury exactly what you mean by "looking around"?

A. Well, she was looking towards the street and in my backyard, and just looking around.

Q. Then what happened?

A. Well, then the car pulled up and she took a little skip before she started to run, and she went across the back of the car and into the opposite the driver's side.

Q. Could you observe the driver?

A. Well, I seen an outline, but I didn't, I couldn't describe his face.

Q. Did the driver do anything as far as.....

A. I just seen the hand.

Q. Would you show us what you mean by "seen the hand"?

A. Well, just, you know, close to the window, I could see a hand movement.

Q. What happened when Jennifer got into the car?

A. Well, they drove away.

Q. Could you see her get into the car, physically

get into the car?

A. Yes.

Q. All right, now would you describe the car and its'

contents, the best you can recall?

A. Well, it was light green and it was metallic and had the helmet on the back, on the ledge, and a Pennsylvania license number.

Q. Do you recall what the license number was?

A. It was 1, 9 or 7.

Q. Which number in the license was that?

A. The first number.

Q. Did you have occasion to see that car again?

A. Did you have occasion to see that car again?

A. At a later date I seen it on 6th Avenue.

A. No, I don't.

Q. When you saw it on 6th Avenue, where is 6th Avenue in relation to your home?

A. A couple of doors away, it would, it is towards the mountain, it would be south.

Q. You were located on Howard Street, I am pointing to Exhibit No. 42, if you step over here, here is Mountain Avenue and here is 6th Avenue, is that correct?

A. Yes.

Q. And would this be the approximate location of your home on Howard Street?

A. Yes.

Q. Now, where approximately on 6th Avenue did you see that car again?

A. Well, coming across here.

Q. Now, let's return to the 19th of October, the day you saw Jennie Hill, which direction was Jennie going?

A. Up this way.

Q. That would be going towards the mountain, is that correct?

A. Yes, south towards the mountain.

Q. On Howard Street?

A. Yes.

Q. Now, which way was the car that picked her up

going?

A. The same direction.

Q. In other words, it was going south on Howard Street, where did the car stop?

A. In the front of the house, next door.

Q. Could you tell whether or not Jennifer got in the front seat or back seat of the car? By Mr. Fierro:

I object to his leading the witness.

By The Court:

Refrain from leading the witness.

By Mr. Ertel:

Q. Do you know, could you tell which door she got into the car, if any?

A. Yes, I did say that the front, opposite the driver.

Q. Did you see that car again, after you saw it on

6th Avenue?

A. I don't know whether I saw it after on 6th Avenue am

Q. I see.... By Mr. Fierro:

She didn't finish her answer.

By The Court:

Q. Was your answer finished?

A. What, on 6th Avenue?

Q. Your answer to the question?

A. I seen the car again in the garage, but I don't know whether it was before I saw it on 6th Avenue or after. By Mr. Ertel:

Q. Where did you see it in the garage?

A. The Borough Hall Garage.

Q. Were you able to identify the car at that time?

A. Some things about it, but the damage was confused

me .

Q. What do you mean by the "damage"?

A. Well, I didn't see the damage on the day she got in on the 19th.

Q. What view did you have of the car on the 19th when she got into it?

A. Mostly the back, and a little bit of the side.

Q. Did you see the front of the car at all?

A. No, I did not.

Q. Now, when you observed, can you tell us what that street is like as far as trees and so on, on Howard Street between Mountain Avenue and 6th Avenue?

A. There is a lot of trees on it, all on one side.

Q. Which side?

A. Well, in front of our house there is two, and then there is three across the street, and a big Oak tree in the side yard of the, across the street.

Q. I am not sure if you answered this, could you tell me if there were more than one person in the car before Jennifer Hill got in or after she got in?

A. I only saw one person.

Q. Now, can you describe how Jennifer Hill was dressed?

A. She had a football jersey on with the number "33", and she was carrying a pink and white plastic bag and a jacket on the left arm, blue with a white stripe some where, and black and white sneakers.

## CROSS EXAMINATION

By Mr. Fierro:

Q. Mrs. Nevel, you testified previously at the preliminary hearing in this matter, didn't you?

A. Yes.

Q. You are saying, Mrs. Nevel, that you are watching television, you are concerned because you have to put your cat to sleep that night?

A. Yes.

Q. So while you are watching television, you are distracted because you see somebody walking outside on your sidewalk?

A. Yes. I don't keep my eyes glued to a TV set. Nobody went up the street that day.

Q. That is what attracted your attention to that fact, that nobody went up the street that day, so as soon as you saw somebody you got curious?

A. I am always curious about the children that go up and down the street, I watch them come home from school, watch them go to school.

Q. So you got curious about thischild, although you know that day your child was off school?

A. Yes.

Q. School was out?

A. Yes.

Q. Was there any particular reason for you to be curious about that child?

A. Well, she looked close to my daughter's age and I wanted to know if she knew her and she was pretty, and I just thought, well I just asked her if she knew her.

Q. You are sitting watching television, you are sitting on a chair or couch or something?

A. Yes.

Q. I assume that your window has some sort of curtains on them?

A. Yes.

Q. And while you are watching television, somehow out of the corner of your eye you see a girl?

A. Yes.

Q. Through the curtained windows?

A. Yes.

Q. Walking north on Howard Street, and so you decide to get curious about it and get up, don't you?

A. No, I did not get up.

By Mr. Ertel:

I object to the question, it is a misstatement of her testimony. She didn't....

By Mr. Fierro:

I don't want to know from you what she said, just your objection.

By The Court:

It was answered, proceed.

By Mr. Fierro:

Q. You did see this girl through the curtains, didn't

you?

A. Yes.

Q. So you get curious, and you say to your daughter, "Who is this girl?"?

- A. Yes.
- Q. Is that right?
- A. Yes.
- Q. Now, do you still remain seated?
- A. Yes.

Part WX Q. Does your daughter get up and go to the window?

- A. Yes.
- Q. Your daughter says, "Well, that is Jennifer Hill."

172.

- A. Yes.
- Q. Now, your daughter goe's back and sits down?

A. I don't know that she went back and sat down,

I don't know that.

Q. You don't know that?

A. No.

Q. You know you made an excellent identification of Jennifer Hill's clothing, you know that, don't you?

A. Yes.

Q. But you don't know whether your daughter went back and sat down?

A. I was looking out the window, my head was looking out the window.

Q. Your head was looking out the window, your daughter was at the same window, wasn't she?

A. She was at the same window, yes, but I was not looking at her.

Q. You were not looking at her, but she is looking out the same window?

A. Yes. Fage 211

Q. Don't you know whether your daughter is standing by the window?

A. She was not standing.

Q. Let me ask the question .....

Q. You said she was standing.

Q. Wasn't she standing?

A. No, Sir.

Q. Your daughter remained seated?

X A. She got up and <u>came over</u> and got on her knees on the couch, opened the curtains and looked out.

Q. So we know now your daughter get up from whereever she was seated, she went over, she knelt on the couch, she parted the windows, and that is the window you were looking out of?

By Mr. Ertel:

I object, nobody can part windows.

By Mr. Fierro:

Q. Parted the curtains?

A. I have double windows.

Q. The curtains you parted, wereyou looking through that section of the window?

A. I was looking through the other section, they are

double windows, she was on the other section.

Q. You were looking through the windows, the curtains were not parted, not parted through the windows you were looking through?

A. Yes, I opened them.

Q. Did you get up or were you able to remain seated?

A. I could turn, the couch sets across the two

windows, the front window is that way, and when I seen her come up Howard Street I watched and I turned and kept on watching her.

Q. Did you part the curtains?

A. Yes.

Q. All right, you parted the curtains too, and you are asking your daughter who this girl is and she says, "It is Jennifer Hill."?

A. Uh-huh.

Q. And so you continued to watch her?

A. ( Uh-huh. )

Q. When you first saw her, where was she, like in front of so and so house, where was she?

A. When I firstsaw her?

Q. Yes?

A. The, I first caught a glimpse of her at my front door, she looked at my front door, there was a Halloween decoration on it.

Q. How do you know she looked at your Halloween

decoration?

A. She looked at the door, she had to see it.

Q. How do you know she looked at the door?

A. Well, that is where her eyes were looking.

Q. How do you know her eyes were not simply looking in the direction of your house?

A. Well, I can tell when somebody is looking at my door.

Q. You can?

A. Yes.

Q. All right, you can tell when somebody is looking at your door, now you can also tell this Jury that you can tell that she was looking at your Hallowsen decoration, can't you?

A. Yes.

Q. And that is what you are telling this jury, aren't you, that when you saw Jennifer Hill you can tell from the way her eyes were looking, that they were looking at your Halloween decoration?

A. For an instant, yes.

Q. That is what you are saying?

A. Yes.

Q. What did she have in mind as she was walking up the street?

By Mr. Ertel:

I object.

By The Court:

The objection is sustained.

By Mr. Fierro:

I don't like this chatter back here.

By The Court:

The Court will clear the Court Room, those that are making the noise, unless it stops immediately. By Mr. Fierro:

Q. In any case, you do know what her eyes were looking at, don't you?

A. At that particular, there, yes.

Q. Now, you said that she was turning her head?

A. Yes.

Q. From side to side?

- A. Yes.
- Q. Right?

A. She was looking around.

Q. She was looking around?

A. Yes.

Q. Now, since you know that she was looking when she looked at your door, since you know she was looking at your Halloween decoration, when you say she was looking around, what was she looking for?

By Mr. Ertel:

Objection.

By Mr. Fierro:

Only to test her credibility.

By The Court:

Sustained.

By Mr. Fierro:

Q. Of course, you don't know what she was looking for,

do you? By Mr. Ertel: Objection. By The Court: The objection is sustained. By Mr. Fierro: Q. Do you even know if she was looking, can you tell that? A. Sure she was looking. Q. Do you know at what? By Mr. Ertel: Objection. By Mr. Fierro: If she knows. By The Court: The objection is sustained. By Mr. Fierro: Q. Describe again how she was dressed?

A. She had a football jersey on, blue and white, number "33", and she had black and white sneakers, and what she was carrying.

Q. Tell us?

A. Well, the pink and white plastic bag, and a jacket on her left arm, it was blue with a white stripe somewhere.

Q. What did you notice about her jeans, were there any unusual markings?

A. I didn't notice them.

Q. You didn't?

A. No.

Q. Mrs. Nevel, you say that a car drove up, green, now you said "metallic" green?

A. Uh-huh.

Q. Is there any difference between that and acrylic green?

A. I don't know what acrylic green is.

Q. Do you know what metallic green is?

A. Yes, it has a brightness about it, shiny.

Q. Does acrylic green have a brightness about it?

By Mr. Ertel:

Objection, she said she don't know that, what that

is.

By The Court:

Sustained, reword your question.

By Mr. Fierro:


Q. Do you know the difference between acrylic green and metallic green?

By Mr. Ertel:

I object.

By The Court:

You may answer?



Q. Are you a paint expert of some sort? A. No.

Q. You are not?

A. No.

Q. You see this car moving south on Howard Street, right?

Q. Now, at the time you see this car, you, of course, are still watching Jennifer, aren't you?

A. Yes.

Q. From the time that you saw Jennifer when she got opposite to approximately where your front door is, once having found out from your daughter that it was Jennifer, you simply didn't go back to watching TV, you continued to observe Jennifer, didn't you?

A. And the car.

A. Uh-huh.

Q. And this metallic green car pulled up opposite to where Jennifer was standing or walking, is this true?

A. Opposite, what do you mean "opposite"?

Q. Well, it was near where Jennifer was?

- A. Yes, it stopped.
- Q. And you saw a hand?
- A. Yes.

Q. That seemed to beckon?

A. It seemed that way, it moved.

Q. At least you can see the hand, couldn't you?

A. Yes.

Q. Now, this is a hand of a person behind the driver's wheel, right?

A. Uh-huh.

Q. So you could see that far, see that much of the car, couldn't you?

A. Yes.

Q. You couldn't tell whether it was a man's hand or woman's hand, could you?

A. It was a man's hand, yes.

Q. It was a man's hand?

A. Yes.

Q. Tell the Jury how you can tell from where you were in your room of your house that it was a man's hand?

A. Well, the size of it.

Q. Tell the Jury about the size of it?

A. Well, you can tell a man'shand from a woman's hand.

Q. Tell us how you can tell, I mean in this case, that

it was a man's hand and not a woman's hand?

A. The knuckles were too big for a woman.

Q. Now, let's see how far away were you from this

car when you saw this hand?

A. I don't know, I didn't measure it.

Q. Well, you have some idea, Mrs. Nevel?

A. I do not, I did not measure.

Q. Was it the length of this room from where you are seated, is that how far the car was?

A. It is hard to tell from the inside to the outside, to judge from the inside, when you go outside it is different.

Q. I am trying to find out if you can use any object in this room to tell this Jury how far away this car was when it stopped to pick up Jennifer from where you were seated, was it the length of this room or any object in this room, or further than this room?

A. Well, it wasn't further than the length of this room.

Q. Well, was it about the length of this room?

A. Well, gee, I couldn't judge until I was outside, I could tell you better outside than inside.

Q. Was the car, Mrs. Nevel, as close to you as I am, or further?

A. Well, it was further than you.

Q. Was it further than where I am standing now? (Standing near entrance to Court Room.)

A. No, I would not say.

Q. Back here? (At last row in Court Room.)

A. No.

Q. How about this? (Next to last row.)

Give us your best estimate?

A. Well, back a little bit.

Q. Possibly around here?

A. I didn't measure.

Q. I am asking for a fair estimate, would this be your best estimate of the distance that the car was away from you when it stopped to pick up Jennifer?

A. It was not in a straight line like that. (Mr. Fierro standing near back row of seats on the righthand side as you enter the Court Room.).

Q. What was not in the straight line?

A. I was not looking straight like that.

Q. You were looking towards the lefthand side of th car?

A. The back.

Q. And the lefthand side, or you couldn't have seen the hand, could you?

A. Yes, I saw the hand.

Q. Well, that means you could have seen the lefthand side of the car because that hand was on the lefthand side of the car?

A. Yes.

Q. And behind the driver's wheel, wasn't it?

A. Yes.

Q. Now, at the distance we just indicated to this Jury you could tell whether that hand was male or female, couldn you?

A. Well, not only the hand, but the head, I seen the

Q. Did it have hair like, maybe like a woman would wear?

A. No.

Q. Was it short cropped?

A. It didn't seem that way, just dark.

Q. Just dark hair?

A. Yes.

Q. You could see that through the rear window of the car, couldn't you?

A. No.

Q. Where did you see it?

A. From the side.

Q. From the side window of the car you could see it was dark hair?

A. Yes.

Q. Could you see that it was long?

A. It wasn't real long, no. I didn't see long hair.

Q. Well, look at Kim's hair, was it like that?

A. The same color.

Q. The same color, but was it like his hair now?

A. I couldn't see that good that it was, I know it wasn't long, not down his back, I know that.

Q. You couldn't see that well about his hair or her hair, whoever the person was, right?

By Mr. Ertel:

Objection.

By The Court:

The objection is sustained, reword your question.

By Mr. Fierro:

Q. I will go on. Now, you say from that distance you could see the knuckles were too large to be a woman's hand, is that right?

A. Yes.

Q. Isn't that what you said?

A. Yes.

Q. That hand did not go outside of the car, did it? A. No.

Q. You had to see it through the glass, didn't you?

A. Uh-huh.

Q. And that is the glass in the front door of that car, isn't that true?

A. Right.

Q. Did you see any damage on either one of the two lefthand doors of that car?

By Mr. Brtel:

May I have that read back?

By Mr. Flerro:

I will ask it again.

Q. Did you see any damage on either of the two lefthand doors of that car?

A. No, I wasn't looking at the bottom part of the car.

Q. You were not looking at the bottom part of the car?

A. I was looking mainly trying to get a good look at

who was in the car.

Q. You were curious about who was picking up Jennifer?

A. Yes.

Q. Now, can you explain to us why your eyes were able to see the front window of the lefthand door, but not see below that and see the panel part of the door? By Mr. Ertel:

I object to the question.

By The Court:

The objection is sustained.

By Mr. Flerro:

Q. You did testify under direct examination that you did not see any damage when you saw this car, isn't that what you said?

A. Yes, on the 19th.

Q. That is what we are talking about?

A. Yes.

Q. Now, you made the statement that you didn't see any damage, does that mean you didn't see any because you didn't know there was any or you didn't see any because you didn't look?

A. Because I didn't look.

Q. Now, the lefthand side of the car that you were facing as you were looking out the window, is that right?

A. No, mostly the rear part and the back side. It was in the middle of the street, it didn't pull up to the curb.

Q. Middle of the street, which put the car further out, so you had a better view of the car?

By Mr. Ertel:

I object to that, I don't understand that question.

By The Court:

The objection is sustained, reword your question. By Mr. Fierro:

Q. Didn't you have a better view of that car because it was out in the middle of the street rather than the curb, closer to you?

A. No, I would have had a better view at the curb. It would have been closer.

Q. It was out in the middle of the street, you think?

A. It stopped in the middle of the street.

Q. The righthand side of the car is the car that is away from you, isn't it?

A. Yes.

Q. That was the hidden side of the car, wasn't it?

A. Yes.

Q. Yet you are able to tell, without being able to see the righthand side of the car, which door she got into?

A. Oh, yes.

Q. Sure?

A. Because I seen her get into it.

Q. You could tell without being able to see the doors, is that correct?

A. You mean she got opposite the driver's side, yes.

Q. Were you able to see the doors on the righthand

side of that car?

A. No.

Q. Now, the Police questioned you about this thing,

didn't they?

A. Un-huh.

Q. You mean "yes"?

A. Yes.

Q. More than once, isn't that right?

A. Yes.

Q. In fact, you were taken to the Borough Hall where this car at one point in time was placed, isn't that correct?

A. Yes.

Q. And there were what, two or three Officers there when they asked you to come down?

A. Two.

Q. Doyou know their names?

A. Yes, Lieutenant ....

Q. Lieutenant what?

A. Well, I can't pronounce it.

- Q. Hynick?
- A. Yes.

Q. Somebody else?

A. Yes, Captain Ross.

Q. That is a South Williamsport Policeman?

A. Yes.

Q. Were they the only two that was there?

A. Yes.

Q. You were asked to identify the car that was there

at the Borough Hall, weren't you?

A. Yes, Uh-huh.

Q. You mean "Yes" ?

A. Yes.

Q. In fact, one of these two Officers said to you, "Mrs. Nevel, is this Kim Hubbard's car?", isn't that right?

A. No, I didn't know whose car it was.

Q. What did they say to you?

A. They didn't say whose car it was.

Q. What did they say to you?

A. "Is this the car you seen?".

Q. Did they say when?

A. Yes, on October 19th.

Q. Is this what they said to you, Mrs. Nevel, "Is this the car you saw on October 19th that Jennifer Hill got into?", is that substantially what they asked you?

A. I don't know for sure, but it sounds like that would have been what they asked me.

Q. Well, you were there?

A. Yes.

Q. And you answered them, you said, "I cannot say it was and I cannot say it wasn't."?

A. Yes, because of the damage, I didn't notice the damage.

Q. You didn't notice the damage?

A. Yes.

Q. Which was on the lefthand side of that car, isn't

that right?

A. Uh-huh.

Q. You mean "Yes"?

A. Yes.

Q. There were two items of damage, one on the door, one on the left fender, right, that you saw at the Police Borough Hall?

A. Yes.

Q. It was pointed out to you, wasn't it?

Q. Madam, didn't you tell the Police that you could not say whether that was the car or whether it was not? By Mr. Ertel:

I object, he is now badgering the witness. By Mr. Fierro:

I am always badgering whenever they are saying something that you don't like.

By Mr. Ertel:

No, Mr. Fierro, you are always badgering when you repeat the question eight times. By Mr. Fierro:

I have to repeat it because I have not gotten a precise answer.

By The Court:

Read the question.

(Official Reporter read question as follows: "Q. Madam, didn't you tell the Police that you could not say whether that was the car or whether it was not?")

By The Court:

The objection is over ruled, you may answer. A. I didn't say it was and I didn't say it wasn't. By Mr. Fierro:

Q. Precisely. Do you remember at the preliminary examination when I asked you about that identification of the car there at the Police Borough Hall?

A. Yes.

Q. Didn't you answer then, you made the statement that you told the Police, "I cannot say that that was the car, and I cannot say that it wasn't the car.", do you remember that?

A. Uh-huh.

Q. You mean "Yes."?

A. Yes.

Q. Now, do you remember, Mrs. Nevel, that somebody pointed out a white helmet to you on the ledge of this car? A. No, I seen it there.

Q. You seen it there at the Police Borough Hall?

- A. Uh-huh.
- Q. Did somebody mention it to you?
- A. No.

Q. Did somebody say that, "Did you see this before?"?

- A. I don't recall.
- Q. You don't recall?
- A. No.

Q. I know the District Attorney asked you that at the preliminary hearing, didn't he?

- A. Yes.
- Q. He pointed to it in the photograph, didn't he?
- A. Yes.

Q. He said to you, Mrs. Nevel, "This white helmet, did you see this on the ledge of the car that picked up Jennie on October 19th?", that is what he asked you?

A. Yes, I seen it on October 19th.

- Q. No, this is what he asked you, didn't he?
- A. Yes.

Q. And you said "Yes.", that that the car you saw pick up Jennifer on October 19th had a white helmet on the ledge, isn't that what you said?

- A. Yes.
- Q. And, in fact, you are saying it today, aren't you?
- A. Yes.
- Q. And you are saying today that although the lefthand

side of the car was exposed to your view, you cannot tell this Jury where you saw any damage on the lefthand side of the car, can you?

A. No.

Q. Now .....

Q. But I got venetian blinds and one of the slats may ave been in that area.

Q. Sure....

A. Where the damage was, yes, it could have been.

Q. Sure it could have been, there is something ....

A. A slat in the blind.

Q. There is something about your window..... By Mr. Ertel:

I believe she is able to answer the question. By Mr. Fierro:

Q. There is something about your window, the way you are saying, or the way you held open the slats might have intefered with your vision?

A. With that particular spot.

Q. Are you telling this Jury that one of the slats obstructed your vision?

A. No.

Q. That is what I want to know?

A. It could have.

Q. I am asking you if it did?

By Mr. Ertel:

Objection.

By The Court:

The objection is sustained.

By Mr. Fierro:

Q. Did you have any obstructed vision when you are looking at this car on October 19th, from whatever source?

A. No, I saw it.

Q. All right, you saw it. Now, if you saw it, can you explain to this Jury why you didn't see that crushed left fender and dented left panel of the door? By Mr. Ertel:

I object to the question.

By The Court:

The objection is sustained. By Mr. Fierro:

Q. Of course you know, you said you saw one of the first numbers of the license plate, you gave three different numbers, didn't you have that car in sight long enough that you could have picked up the entire license plate number?

A. No, it was too fast.

Q. Too fast?

A. Yes, it stopped, she ran in and away it went, fast.

Q. But you got three of the 10 digits, you don't know which one was the first one, you are just saying it has to be.....

By Mr. Ertel:

There are not ten digits in a license number in the State of Pennsylvania.

Q. Do you understand the question?

A. No.

Q. Do you understand the question?

A. No.

Q. Reword the question.

By Mr. Fierro:

Q. One of the single most important items of identification concerning the car that picked up Jennie on October 19th was this white helmet on the ledge, isn't that right?

A. And the metallic.

Q. And the metallic green, okey.

Q. Now, you are sure, Mrs. Nevel, that on

October 19th at 4:30 this metallic green car that picked up Jennifer Hill had a white helmet sitting on the ledge of that car?

A. Yes.

Q. You are sure of that, aren't you?

A. Yes.

Q. In fact, you are positive of that, aren't you?

Q. Mrs. Nevel, do you know as a fact, I am asking you if you know, that the only white helmet that Kim Hubbard owned was the one that he got on October 24th when he went to work at Stroehmann Brothers, do you know that? By Mr. Ertel:

I object.

A. No, I don't know that.

By Mr. Flerro:

A. Yes, I was not reading it.

Q. Why not?

A. Well, that week I was upset about my pet, and I was busy sewing for the Mummers' Parade that was to come up, and until the paper came I was busy with dinner, and then I would sit down at the sewing machine, and I just didn't bother reading it until Sunday morning when I picked up the Grit and I started to read and I said to Beth we.....

Q. I am not asking what you said to anybody, I want to know about your readingSunday morning, this is October 29th,

probably October 31st, that Sunday nevertheless, was the first that you read in the newspaper about Jennifer's disappearance, isn't that right?

A. Yes.

By The Court:

Now, Mr. Fierro, if you want that date I have the 1973 Calendar in front of me, it shows that Halloween was on October 31st, which was a Wednesday. Any objection, Mr. Ertel? By Mr. Ertel:

If that is when it was, that is when it was. By The Court:

Proceed.

By Mr. Fierro:

Q. Now thatyou heard the, what the Judge has said concerning Halloween, which was October 31st, on a Wednesday, I will go back, did you go down to the Police Borough Hall and see that car before or after Halloween, if you know?

 $\vee$  A. I don't remember whether it was before or after Halloween.

Q. Now, let's go back as to when you read the paper whichwas on Sunday, the Sunday after Jennifer's disappearance, you read the paper and you knew because you read her name, and you knew who she was, your daughter told you, read that Jennifer Hill had been missing since Friday, isn't that right?

A. No, it was Sunday morning around 9:00 in the Grit, that was the first I felt like even reading anything. It seems to me I only remember about when it came to the football jersey, then

it brought back everything. If I had read the Sun-Gazette or listened to the radio. I would have remembered it sooner.

Q. For whatever reason you didn't listen to the radio or read the Williamsport Sun, we know you did now read and know all about Jennifer and it came back to mind that Sunday morning, is that correct?

A. Yes.

Q. You continued to read the paper in the following days concerning the search for Jennifer, didn't you?

A. No, I didn't keep up with it, no, I didn't.

Q. You didn't?

A. No, I did not.

Q. On Sunday morning, Mrs. Nevel, perhaps October 31st, you read in the Grit about Jennifèr's disappearance and there was a search going on for her, and you just said it all came back to you?

A. I don't remember reading.

Q. Now, are you testifying that you thereafter did not continue your interest in this matter by reading the papers?

A. Not everything, no, I didn't, I never do read everything.

Q. Didn't you care?

A. Yes, I cared.

Q. When you read about Jennifer's disappearance on October 31st and it brought back everything to you..... By Mr. Ertel:

I object.

By The Court:

The objection is sustained, October 31st was a Wednesday.

By Mr. Fierro:

Q. Excuse me, Sunday, the following Sunday, the girl disappeared on October 19th, I am sorry, and you read about it in the paper the following Sunday?

A. (Uh-huh.

Q. The 21st, probably? I am sorry, I stand corrected, I had Halloween on my mind, we will go back to make sure, she disappeared on the 19th, you know that, don't you?

A. Yes.

Q. The following Sunday, which would be the 21st of October, you read about it in the Grit, is that correct?

A. Yes. C.C. Q. You said it all cameback to you then?

A. Yes, and what I saw, I saw her, yes.

Q. You remembered then, reading this article, that you saw Jennifer get into a car at 4:30 the previous Friday, you remembered that, didn't you?

A. Yes.

Q. You mean you did not ....

A. I did not continue to read, I said we remembered it, I said to Beth.....

Q. You did not continue to read the paper?

A. I did not continue to finish the article, no.

Q. But did you learn from that article, whatever you read of it, that she disappeared Friday?

A. I had heard she disappeared before, that Friday.

Q. You mean you learned it from people?

A. Yes.

Q. When did you hear it, like the day before, Saturday?

A. Not until the day after.

Q. All right, the day after was Saturday, she disappeared Friday, you read the paper Sunday, did you hear about it that Saturday?

A. You mean the Sunday, she disappeared on the 19th, you mean that Sunday?

Q. Yes, you said you read the paper?

the A. No, it was the following Sunday, it was nine days later.

Q. You, are you saying you didn't read a paper

for nine days later?

A. No, I did not.

Q. You did not?

A. No, the day after, I didn't know she disappeared until the day after.

Q. Well, you found out later, you found out Saturday she disappeared, didn't you?

A. Yes.

Q. Then probably you heard it from other people even the next few days about this matter, didn't you?

A. Well, I heard, yes, I heard things.

Q. Because you heard or somehow new there was a search going on for her, isn't that correct?

And Now, to-wit, Friday, February 22, 1974, beginning at 9:00 A.M., EDST, the trial in the above-captioned matter was continued before the Honorable Charles F. Greevy, President Judge, and a Jury, in Court Room No. 1, at the Lycoming County Court House, Williamsport, Penna., at which time and place the following proceedings were had: (IN CHAMBERS.).

By Mr. Fierro:

On the record. Your Honor, I requested this conference for this reason, prior to this morning the District Attorney has told the Court that he probably will have Officers testify concerning the Defendant's inconsistent statement as to his whereabouts prior to 4:00 P.N. on the day that Jennifer Hill disappeared, and the Defense then argued to the Court that if that were allowed in, the question of smoking "pot", the buying or selling or giving or the smoking of it might forcibly become introduced, thus prejudicing the atmosphere of this trial. I am now here to say that the Court, and add to my argument this, that it now appears from the Commonwealth's testimony, and unquestionably will later on, that there was no contact between the Defendant and the decedent at least prior to 4:00 P.N., or perhaps 4:30, if one of the witnesses is to be believed, but to allow the Commonwealth all latitude, from guarter to four, prior to quarter of four there was no contact between the deceased and the Defendant in any manner whatsoever. Assuming that the Commonwealth proves contact later on, I agree, that is admissible, but I am saying to the Court the Defendant's movements prior to

that time, since there was no contact at all, do not relate at all to what happened beginning at 4:00 P.M. and are no more germane than what he did a week before, since they are not related to the issue here. Now the purpose of this, Commonwealth's Exhibit No. 57, is to show the markings on the neck which is a strangulation mark and it shows the petechiae of the eyes, but it shows the strangulation marks from which he can draw conclusions. Here are the markings on the neck, and that is the main purpose of that.

By The Court:

The same argument, Mr. Fierro?

By Mr. Pierro:

Even more so, your Honor, if he wants to use this to show strangulation marks on the neck, he is exhibiting, to put it bluntly, an ugly corpse that appears to have been manhandled, and that inference may be drawn by the Jury. How, the markings on the neck the Doctor does not need this photograph to will the Jury that he saw markings on the neck, he can say so without showing this photograph, and when Mr. Ertel talks about the word he used, it was petechiae, what he means is the breaking of small blood vessels under the skin which the Coroner or some other Doctor can say when a person is manually strangled there is a breaking of small blood vessels under the skin, and it appears in various places, without showing this disturbing photograph. By The Court:

The next slide.

By Mr. Ertel:

The next would be 58, that is to show the markings on the back of the neck and the midline, which are external markings here, of thumbpring or nailprint, I should say. By Mr. Fierro:

I think the District Attorney should go further, I think if the Bistrict Attorney is going to establish that thumbprint belongs to the Defendant, I agree that this can be shown, but it must be established through a fingerprint expert. If the District Attorney says he cannot establish that, that this belongs to the Defendant, then I say it is useless and the Coroner or the Forensic Pathologist can say, "Yes, I found a thumbprint.", and he can describe where. Now, I am asking the District Attorney, is that thumbprint, does the Commonwealth expect to prove that thumbprint is the thumbprint of the Defendant?

By Mr. Ertel:

By circumstantial evidence, yes.

By Mr. Fierro:

No, by fingerprint evidence?

By The Court:

We won't argue at this time. Is that your last one?

By Mr. Ertel:

Yes, Sir.

(Off-the-record discussion.).

(Jury entered Court Room at 9:45 A.M., EDST.). (Doctor Earl R. Miller returned to witness stand.) By Mr. Ertel:

Q. Doctor Miller, yesterday you were looking for a photograph, have you cleared that up in your mind as to which photograph you were looking for?

A. There was not one taken at the time, I recalled that there had been one taken.

Q. Now, I show you what is Photograph 11, can you identify that, please?

A. Yes, that shows taking a measurement of an imprint on the ground, lateral to the body at the level of the knee.

Q. Is that a fair representation of what you saw at that time?

Q. I show you marked as commonwealth's Exhibit No. 12, can you identify that, please?

A. Yes, Sir.

Q. This is what?

(A. This is a picture of the, of a fresh cast and imprint into the ground, which is at the, at the right shoulder level of the body. The body is not shown in this picture, the body has been removed.)

Q. Is that a fair representation of what you saw on that particular day?

A. Yes, Sir.

Q. I show you marked as Commonwealth's Exhibit No. 2, can you identify that?

A. Yes, this is a picture that was found, or I am sorry, this is a picture showing the stick that was found under the body and which we have used as a point of reference for multiple measurements and geographical location of imprints with the body after the body has been removed. This shows a ruler measuring an imprint that is next to and over the stick.

Q. Is that a fair representation of what you saw on that particular day?

A. Yes.

Q. I show you marked as Commonwealth's Exhibit No. 14, can you identify that, please?

A. This is a picture showing some vegetation and my arm and a rule, and I need another picture in order to localize it for the people.

Q. I show you Commonwealth's Exhibit No. 20, is that the one you wish to look at?

A. Yes.

Q. Can you identify that one, please?

A. Yes, this is a picture after the cast, plaster of Paris cast has been made of the representative footprint scene and it shows a stick which is again was under the body. It shows corn stalks which have been cut. In relationship then to your Exhibit No. 14, you can see the vegetation relating to the cast which was at the level and outside of the right shoulder. Says one cast The theorem Theorem 265

Q. And is that a fair representation, Commonwealth's Exhibit No. 14, of what you saw at that particular time?

A. Yes.

Q. We will come back to Commonwealth's Exhibit No. 20, so let's keep that out, please. I show you marked as Commonwealth' Exhibit No. 15, can you identify that, please?

A. Yes, this shows the rule measuring another imprint into the ground, and I can orient it with Photograph No. 11.

Q. Is that a fair representation of what you saw at that particular time?

A. Yes, Sir.

Q. Now, in relation to Photograph No. 11, can you orientate that as far as where the body was located?

A. The easiest thing to identify is the two big globs of dirt, the rectangular identification you can see, the lower one in the picture is just laterally and to the left of the left lower leg of the body. The other one is almost at the knee level, but is more lateral or more left to the left leg of the body. These two objects are easily identified.

Q. Are these a fair representation of what you saw on that day?

A. Yes.

Q. I show you marked as Commonwealth's Exhibit No. 17 canyou identify that?

A. Yes, Sir.

Q. What is that?

A. This shows the rule lying at the end of the stick and inside of the original cast, it was an imprint which was partially obscured by the victim while the victim was lying on the ground and at the right side of the victim.

Q. Was that a fair representation of what you saw on that particular day?

A. Yes, Sir.

Q. Now, turning to Commonwealth's Exhibit No....

15 WEF-1

A. These, just by comment, Sir, these two films also on 16 and 12 show the plastic material that we put over some of these casts because it had started to rain.

Q. Now, turning to Commonwealth's Exhibit No. 20, can you identify that?

A. Yes, Sir, again shows the cardinal point, shows the stick which had not been moved, it shows the plaster which had been poured into the imprints. The picture was taken for orientation, for identification before these prints, before these casts were moved from the specific imprints.

Q. Is that a fair representation of what you saw at that particular time?

A. Yes, Sir.

Q. Now, turning to Commonwealth's Exhibits Nos. 1 through 8, can you re-look at those and tell us if they are a fair representation of what you saw on that particular day and identify each photograph if you do?

A. You wish me to identify them?

Q. Just identify the Commonwealth Exhibit Number and

tell me if that is a fair representation of what you saw on that day?

A. No. 1 is the view taken from the path in the cornfield in relatively close proximity to the body. It shows specific ally the legs and the clothing and sneakers around the ankles and the lower extremities.

Q. Incidentally, there is an object to the right of the body there which appears white in the photograph, can you identify that?

A. Yes, that was a part of a pair of pajamas.

Q. Is that a fair representation of what you saw prior to moving into the body?

A. Yes, Sir. No. 2 is the same scene a little bit farther towards the road. You can see the same objects, although the pajamas are more obscured by vegetation, corn and weeds

Q. Is that a fair representation of what you saw on Gradination of what you saw on Gradination of that day?

A. Yes, Sir. Q. Go on? Switches Picture on Jury Page 310 A. No. 3 shows the body with the jacket pulled down ---- Fielos 151105

over the torso and upper thighs and this picture was taken from the south side of the body and it shows a white object here which has the "Glick" name on it, and I know it to be a Glick shoe bag. If you, I know it to be a Glick shoe bag, if you look at it intently you can see grey on this black and white picture, you can see the grey stripes of the bag.

Q. On the photograph that is black and white?

258.

A. Yes.

Q. Is that a fair representation of what you saw on that day?

A. Yes.

Q. Continue with No. 4, please?

A. No. 4 shows the same material as viewed from the other side of the body, namely the north side of the body and therefore you are seeing the detail of the right body. You can even see the Glick shoe bag above the body in the, in this picture, and the stripes are easier to see on this picture.

Q. Is that a fair representation of what you saw?

A. Yes, Sir. No. 5 shows the body with the jacket having been pulled down by myself, demonstrating that the right arm is still in the upper part of the sleeve of the jacket.

A. Yes, Sir. No. 6 is the same, the body and jacket have not been moved, but this shows a picture from the other side of the body, namely the north side and it demonstrates that the hand is still in the upper part of the sleeve of the jacket.

Q. Is that a fair representation of what you saw on that day?

A. It is. No. 7 shows the body as we approached it from the east. The cardinal point of interest is that it shows the left shoulder being supported up off of the ground by a corn stalk which is pointed, I know it to be pointed to the east, in this picture it shows it pointing to the right. The significance

being this demonstrates the position of which the body came against the corn stalk.

Q. Do you know that to be a fair representation of what you saw on that day?

A. Yes, Sir. The other point, if I may add, shows the left ear without an ear ring.

Q. All right?

A. The last picture you handed me, No. 8 ....

Q. Doctor, No. 7, was that a fair representation of what you saw?

A. It was. No. 8 shows the head from the, with the camera from the right side depicting the fact there is an ear ring in the right ear. It also shows my hand pulling the leaves of the corn stalk out of the way so you got a good view.

Q. Is that a fair representation of what you saw on that day?

A. Yes.

Q. (To The Court.). At this point, your Honor, we would like to offer in evidence these photographs and offer him for cross examination as to the photographs.

The Court is going to rule on the photographs at this.



time, if you desire to cross examine strictly on the photographs, I will permit it, 3 ir.

By Mr. Fierro:

No, I am going to wait until this witness is through, and you may rule as the Court sees fit. By The Court:

As I understand now, Mr. Ertel, Nos. 1 and 2 have been admitted without objection of the Defense Counsel, and you are now offering for admission Nos. 3 through 16, is that correct?

Ros. 9 and 10 are different objections, they phete By Mr. Ertel: are not photographs.

By The Court:

No. 9 and 10 I don't have on my list. What you are affering now, would you make it specific? By Mr. Ertel:

It is Nos. 3 through 8, No. 20, 11, 12, 13, 14, 15 and 16. By The Court:

These Exhibits are admitted into evidence over the objection of the Defense Counsel, and the Jury is specifically instructed in regards hereto, these photographs are admitted into evidence for the purpose of some showing the nature of the wounds received by the deceased, some showing the conditions of the scene of the alleged crime and others helping you to understand the testimony of the witnesses who have referred and will refer to

them. The photographs of the deceased are not pleasant photographs to look at. You should not let them stir up your emotions to the prejudice of the Defendant. Your verdict must be based on a rational and fair consideration of all the evidence and not on passion or prejudice against the Defendant, the Commonwealth, or anyone else connected with this case. Those Exhibits are admitted into evidence. By Mr. Ertel:

Q. Doctor Miller, if you will, can you take Photograph No. 20, which you have previously identified as the photograph of the casts, and can you arrange on the floor these objects and identify the objects as you go and then describe where the body was in relation to the cast?

A. Yes, Sir.

By The Court:

See that the objects are marked.

By Mr. Ertel:

They are marked.

By Mr. Fierro:

I would like to know what this experiment is and whether or not this man is qualified to conduct this experiment. By The Court:

May I see Counsel at Side Bar? Might I state again, as I did in my opening remarks, that Counsel and I are required by law to take up certain matters out of your hearing. We may do this at the Bench, as we are doing now, or in my Chambers, or I shall ask you to leave so that we may do so in the Court Room.

262

This morning we did so in the Court Room while you were in the Deliberation Room. You should not concern yourself with any of these proceedings.

(Side Bar Consultation not made a part of the record.). ByMr. Ertel:

Q. Doctor Miller, when you were there, will you describe the process you did in measuring and what happened as far as making of casts, can you go through that in detail?

A. Yes, Sir. As we first approached the body, coming from a wide area around the body, we were looking for footprints or disturbances in the ground. (We found none until we got in the immediate vicinity of the body.) At that time we attempted, or I attemped to make measurements of impressions. Some of these impressions were quite vague and ill-defined. The process of which this was done, was Trooper Houser had a pad of paper and was writing down, I was calling off measurements and roughly orientating them in relationship to the positions of the body, and Houser would call back the measurements to make sure he heard what I was saying. We took, Trooper Keppick and myself, made an imprint, made a cast of the first imprint which looked like it would be reproducable was outside of the lateral to the right shoulder. At that time we were aware that there were other prints partially obscured, particularly one to the right of the body, and obscured by the right arm, so that we could not make a print.

Q. Now, what do you mean by making a print?

A. Making a print is the pouring of wet plaster of Paris solution into the ground and dropping pieces of wire, such as a cut coat hanger into this mould on the top surface of it to give it reenforcing so it would not be broken in being handled and being extracted from the ground.

or dil Mali Luis

Q. Now, continue, please, with your narrative?

A. It become apparent there were other prints which we would be able to make impressions of with plaster of Paris after the body was moved. At that particular time, I spent more time looking at the body and the most obvious things of the body were the multiple petechiae around the eyes, the face, the tongue and on reflection of the eye lids in the conjunctival surfaces of the eye, that being the vascular covering of the eyeball. There was a particular arrangement, sor of linear arrangement of a row of petechiae on the left side of the neck. To me, petechiae in a localized area of the body such as the head and neck in a deceased person is indicative of a strangulation process, and it was at this time that the decision was made that we do, mo not uncover the body or do anything more with the body until we secured the services of a consultant, a Forensic Pathologist. ) At this stage of the game, with myself watching the footprints, making sure that the Troopers who were being used to pick up the body and remove it immediately to the east through the same row of corn, my job at that time was to safeguard that no Trooper stepped anywhere near in this vicinity and by supervision of having them pick up the body and move it, that was accomplished. We then went back, Trooper

Keppick and myself, and he prepared the plaster of Paris and he poured it into the imprints on the ground. I dropped the reenforcing wire into them. We completed this through a total of six imprints, one of which is actually a casting of two imprints, so we eventually have a total of six casts. At that time we had a picture taking, which is specifically being No. 20, and is necessary for the orientation of where these casts came in relationship, the picture shows in relationship to the stick and the previous picture shows the relationship of the stick to the body, so I can identify the relationship of the cast to the body which has been removed.

Q. Now, Doctor, can you identify those casts, prints?

A. Yes, that is the cast which actually is, has two

imprints, and the first one at the lower part of the Picture No. 20.

Q. Where was that in relation to the body?

A. That was underneath the buttocks. We have, that has the deepest heel print of all of that we acquired, and another heel print going in the, or in a slightly diagonal angle to it. These heel prints we did not see until after the body was moved.

Q. Can you mark that on Commonwealth's Exhibit No. 20?

A. (Witness marks.).

Q. I show you marked as Commonwealth's Exhibit No. 52, can you locate that on Commonwealth's Exhibit No. 20?  $\gamma_{A} = 2.75^{-1}$ 

A. Yes, Sir, that is the cast which was immediately  $7_{\rm b}$ , at the end of the stick in No. 20. Q. Can you mark that? Maybe you can write it right on the print itself?

May I have Side Bar?

By The Court:

Except this, I assume that just the cast by itself, unless they see the photograph with it, is probably not going to mean as much to them.

The purpose of the demonstration is to layout the casts approximately in the same location they were in the day they were made, to show the footprints in relation to the location of the body. The measurements are approximately within an inch. He will describe where each one is and point to the one on the photograph, which is Commonwealth's Exhibit No. 5 and also relation to Commonwealth's Exhibit No. 20, which is the photograph when the cast was poured and after the body was removed, and he will probably use other photographs to relate those to the casts and show exactly where these footprints were in relation to the body.

Where is the stick?

A. The back of the shoe is pointing eastward.

Q. Now, were there measurements taken of these prints except for one of them before they were cast?

A. We took measurements of identations on the ground where ever we found them. When the body was moved, and we found the prints which this has made a cast of.....

Q. 51?

A. 51, particularly there are two heel prints under there, particularly one of them is very distinct, was sharply outlined and was the deeper imbedded into the ground than the other imprints. We spent particular attention to 51 and 52 because of the definition of these imprints at that time. There were other imprints we could not cast, and you have 55, is really a poor quality.

Q. And was 51 a good quality?

A. It is very good.

Q. Anything that was able to be cast, was it cast?

A. No, Sir, you could have cast the whole ground.

Q. I mean to get any kind of definition?

A. We cast everything we thought that would give us definition.

## CROSS EXAMINATION

By Mr. Elerro:

I was hoping this would be a good time for a break. By The Court:

Q. Doctor, you mentioned that in your examination of this area, long with the Troopers, that you found many other impressions but they were ill or poorly defined?

A. I found, yes, Sir, right in the immediate vicinity of the body.

Q. Well, when I say "you", I don't mean that you found them alone, maybe the Officers found some. I mean whatever knowledge you and the Officers working concurrently had is all right for you to express under this questioning. In what area surrounding the body, what was the extent of the area A. Oh, within two feet. HAD TO SWY that backuse Q. Surrounding the body? HESKID CO CHUNKY 2FT APART

A. Basically laterally with the body. If you recall, this is in a corn field and the markings that I am talking about are within the confines of which would be basically four rows of corn.

Q. What were they, about 18 inches apart, these rows? Two feet apart?

A. I would imagine they are about two feet.

Q. You say four rows?

A. Would be the extreme extent.

Q. That is eight feet?

A. Yes.

Q. So these various impressions, the good ones and bad ones were within an area of eight feet?

A. The overwhelming majority of these impressions would have been within an area of three feet.  $C_{TA} T_{C} e_{D(C} (x)^2)$ Q. I am talking about all of them, I am trying to

Q. I am talking about all of them, I am trying to find out what the outside perimeter was whatever these impressions were, were they eight feet away?

A. They would be less than eight feet.

Q. You are the one that said four rows of corn?

A. What I am saying, if you look at the

picture, for example, you will see this body lying in between two rows of corn, and just to the outside of those there were a couple ill-defined markings. Now, this would be within an area of two feet of that body.

Q. The extreme outside of the next row of corn which you have deduced to be the eight feet because of the judgment of the corn being two feet?

A. My judgment was less than that.

Q. Four rows of corn, two feet apart?

A. No, Sir.

Q. Let's forget it, let's go on, I want to know how many impressions you saw, good or bad?

A. I did not count all of the markings on the ground.



Q. Give the Jury an idea, an estimate?

A. There perchance was maybe 10.

Q. What you did, of course, you and the Troopers, were you recovered the distinct impressions?

A. That is correct.

Q. You did not try to make a cast of whatyou call the ill-defined impressions?

A. That is correct.

Q. What did these ill-defined impressions look like?

A. Smooth, flattening surfaces of the ground.

Q. Smooth, flattening surfaces?

A. Yes.

Q. In what dimension, what size?

A. Oh, in dimensions maybe two, three inches in diameter, but the problem we had was measuring them because the edges were not definite, were not defined.

Q. How many impressions of foot prints were you able to see, defined well or otherwise?

A. Well, the ones that we, that was recognizable as footprints would be a total of seven.

9. A total of seven? only Took Grosts A. Yes.

Q. Of which you made how many casts?

A. Six.

Q. What about the 7th one?

A. In the cast, in the biggest cast there are two very good footprints.
